What You Get for Your Money

OHCA's inclusive exhibit fee covers:

All exhibitor registrants are permitted to attend the educational sessions (without CEs). An additional fee will only apply if the company representatives wish to obtain CEs.

- Pre-convention registrant list sent via email four weeks prior to show

Payment Schedule:

50% of the fee is due upon booth registration; full payment is due by 4/1/2025. If registering 4/1/2025 or after, full payment is due upon booth registration.
